Terms and Conditions.

1. Eligible Entrants

Entry is open to SPAR, SPAR Express, SUPERSPAR customers who are residents of Australia and over 18 years of age.

Employees of the Promoter and their immediate families, employees of centre management offices, participating retailers and advertising agencies or production companies are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, brother, sister, step-brother or step-sister.

2. How to Enter

Purchase three (3) Participating Products in a single transaction from any Participating Store.

3. Limits on Entry

Participants personal information will be collected by the Promoter. Personal information will be stored on the Promoter's database. The Promoter will use this information for future marketing purposes regarding its products, including contacting the participant electronically. Personal information collected from participants will not be disclosed to any entity located outside of Australia
